Prior to the opening of the meeting, Mr. Groon led those present in the Pledge of Allegiance to the Flag.

The meeting of the Board of Commissioners, Borough of Wildwood Crest, Cape May County, New Jersey, was held in the Municipal Court Room at 9:30 a.m. On roll call the following answered to their names:

Gould – Cabrera – Groon – Yes

Mr. Groon read the following statement: In compliance with the Open Public Meeting Act, Chapter 231, P.L. 1975, the notice requirements have been satisfied as to the time, place and date of holding said meeting by posting notice on the bulletin board in the Borough Hall and by mailing and same to the Gazette-Leader, Herald of Cape May County and The Press on November 4, 2015.

Mr. Groon next announced the one-way in and the one-way out method of ingress and egress in case of emergency.

AN ORDINANCE ADOPTING A CODE OF ORDINANCES

Mr. Cabrera motions, Mrs. Gould seconds that Ordinance No. 1241 be passed on first reading, advertised according to law, be brought up for second and final reading and public hearing on June 22, 2016 at 5:30 p.m.

THE CLERK READS THE FOLLOWING RESOLUTION BY TITLE:

RESOLUTION NO. 702-16

WHEREAS, on May 27, 2016, SHANNON WAGNER, 24-6 Arthur Dr., South Windsor, CT 06074, applied for a Special Events Permit for the purpose of the WAGNER-CUDDY WEDDING to be held on JULY 7, 2016, from 6:00 PM to 7:00 PM, at CENTENNIAL PARK; and

WHEREAS, SHANNON WAGNER, 24-6 Arthur Dr., South Windsor, CT 06074, has supplied all documentation required under Ordinance No. 936, including the requisite Certificate of Insurance, and has further pledged to comply with all applicable rules and regulations pertaining to the conduct of said Special Event; and

WHEREAS, the application has been reviewed by the Board of Commissioners, upon verification by appropriate members of staff as to completeness of the application, scheduling compatibility, etc.;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Borough of Wildwood Crest, County of Cape May, New Jersey that the Borough Clerk be and she is hereby authorized and directed to issue a Special Events Permit to SHANNON WAGNER, 24-6 Arthur Dr., South Windsor, CT 06074 for the purpose of the WAGNER-CUDDY WEDDING to be held on JULY 7, 2016, from 6:00 PM to 7:00 PM, at CENTENNIAL PARK.

The Mayor then opened the floor for public commentary. Bruce McCausland, 102 E. Atlanta Avenue, presented a suggestion for more bike racks along the bike path. He cited issues in Cape May and how at the base of Cresse Avenue there can be as many as 40 bikes locked up. He would like to see bike racks from Morning Glory Road to Cresse Avenue along the bike path. The Mayor then pointed out that there have been suggestions made for bike racks at street ends.

After no further comments from the public, the Mayor opened the floor with new business. There was no new business to discuss; however, the Mayor pointed out that individual permit for the beach was obtained 5 years ago and beach maintenance is recommended and being pursued and beach maintenance will now be separate and it is \$1,000.

There were no updates for old business.

After no further commentary from the public, Mrs. Gould motioned, seconded by Mr. Cabrera that the meeting be adjourned. All were in favor. The time was 9:36 a.m.
