Instructions for Application for Certificate of Smoke Detector and Carbon Monoxide Alarm Compliance

- 1. Complete application form and submit to the Fire Prevention Bureau with payment**
- 2. Inspection will be scheduled as soon as possible prior to the settlement date listed on the application.**
- 3. Check the property to ensure that the following requirements are met:**
 - A. Smoke alarms must be installed and in working order. The smoke alarm must be not older than 10 years. You can find the date of manufacture on the back of the detector. If older than 10 years the alarm must be replaced. Smoke alarms must be located on each level of the dwelling, including the basement (excluding attic/crawl space) and within 10 feet of each sleeping area.**
 - B. Carbon Monoxide (CO) alarms must be installed in any dwelling or property that contains a fuel burning appliance/device (i.e., Natural gas, oil). Carbon Monoxide (CO) alarms must also be installed in any dwelling or property that contains a fireplace (except electric) or has an attached garage. Carbon Monoxide alarms must be installed within the immediate vicinity of all sleeping areas.**
 - C. A fire extinguisher must be installed in the kitchen area of the dwelling. The minimum size fire extinguisher required is 2-A:10-B:C. The extinguisher must either be new with the current year on the extinguisher itself or have a current service/inspection tag in place. The fire extinguisher must be mounted in a visible and accessible location. The extinguisher may be mounted inside of a cabinet, such as under the kitchen sink, as long as there is a label on the outside of the cabinet indicating the location of the extinguisher.**
