#### **Kavak Launch/ Sunset Lake Shoreline Stabilization**

We have executed the required shared service agreement for Cape May County Opens Space funding in the amount of \$302,852 for the recreational improvements at Sunset Lake. As this funding is a reimbursement from the county we must next provide for Crest funds to be utilized up front by designating this project as a capital project and the CFO must certify to the availability of funds for same.

#### **Beach/ Dune Project**

Nothing new to report. We are still awaiting the 60% plans from DEP Coastal Engineering.

## 1) Cape May County Open Space and Recreation Applications 2018

We are awaiting word from the Cape May County Open Space Board on the outcome of our application for the Scoop Taylor and Sunrise Park applications. I still have not received a letter from open space but will continue to keep you updated.

#### 2) New Jersey Prevention Network Get Active NJ

As you know we received this \$3000 grant for the numbering of our bike and walking/jogging trials. I reached out to Zone Striping and asked that they coordinate with the Recreation Dept. regarding the creation and installation of pre-formed thermoplastic numbers to designate mile markers along the bike/walking trails. Nick Holland is working with Vern at Zone Striping to bring this project to completion.

#### **Old Library Building**

We have received our wind damage claim compensation. A reimbursable line item was created in the amount of \$ 121,362.16. This is discussion item on this evening's agenda.

#### Ace Reliability Upgrades

At this point ACE has completed their portion of this reliability upgrade project, however, Verizon is still transferring their equipment to new poles and remove approximately 13 old poles. Jim Kopaz is working with Verizon to ensure the proper street opening permits are in place for this to occur. Yasmine Watkins (representing Verizon) is working to prioritize this work and provide us with a timeline for completion.

### **Affordable Housing Compliance**

As of two weeks ago the courts have provided our Order of Fairness and Compliance and approved our settlement agreement. The Fair Share Housing Center has requested additional time to review it therefore we have been provided with an extension of our immunity until June 30, 2018. According to our special counsel we are not expected to collect development fees until at least then. I will continue to keep you informed.

## Garden State Parkway/ Rt 109 Signage

NJDOT has asked for our patience as they plan for the replacement of directional signage at the foot of the Cape May bridge. We have requested that they add a Wildwood Crest directional sign to the one that currently exists and reads "Ocean Drive." I will continue to follow up and check on the status of this request.

#### **School Funding Legislation Sponsored by Steve Sweeney**

There is a proposal in Trenton being supported by Senate President Steve Sweeney to revert school funding to the full funding formula. According to numbers ran by NJ.com there are only a few school districts that would see an increase in aid as a result and only one with a significant increase- Ocean City. Those numbers show 6 districts that would lose over \$2 million. Crest Memorial School stands to lose \$157,184 according to these numbers. The current proposal by Senate President Sweeney would be phased in over 7 years and would shift the approximately \$9 billion dollars New Jersey spends on direct aid to schools from those districts considered to be overfunded to those considered underfunding (us.) We are definitely on the short end of this stick. I have attached the numbers published in NJ.com for you along with an article that explains Sweeney's position. This legislation would significantly increase the school tax portion of Crest property owner's tax bills or could lead to significant cuts in numbers of teachers and/or services that are offered. Cape May County Freeholders have sent a letter to Van Drew's office asking for opposition to this proposed legislation. With your support I will craft resolution opposing this legislation. I have reached out to NJLOM for the bill numbers and a sample resolution if one exists.

#### **DISCUSSION**:

#### **OLD BUSINESS:**

- -Borough Hall entry and employee access on hold.
- **-Borough Hall IDs for residents** The new tags are in and they will be at the Nesbitt Center to be picked up by residents from 8:00 to 6:00 pm and proof of residency is required.
- -Crest Merchandise specifications on hold.
- **-Old Library** A lengthy discussion ensued. The Mayor and Commissioner Thompson are in favor of keeping the building and renovating it. Commissioner Gould is not in favor of keeping the building and referenced figures to renovate from 2016 and indicated that they most likely have increased. She further added that both the land and the building are valued at approximately \$3,200,000.00.

Vince Nardini, 222 E. Hollywood Avenue, added that he agrees with Mr. Roger Brooks that the building should be renovated and it can offer opportunities and can bring in vendors.

Aileen Kennedy, 122 E. Sweetbriar Road, and can't understand why we tear down the building. She added that the building reflects the history of Wildwood Crest and that it needs historical aspect.

Mayor Cabrera, added that the north side of Crest Pier used to house shops and wants to bring back those shops and wants to move passed the idea of demolishing the building.

Commissioner Thompson, indicated he feels strongly that we need to keep the building and renovate it and that it has potential. He further added it was structurally sound and there are plenty of opportunities there.

Pam Gentek, 5910 Park Boulevard, doesn't understand the vision for the building and there are plenty of rooms at Crest Pier.

Dan, Ocean Property Management, was in favor of keeping the building and preserving the history and would like to see the historical society in there.

Jack Morey, 5901 Ocean Avenue, likes the open dialogue and that the Governing body continues to embrace public space and would like to see the building saved.

Marie Nickerson, 8801 Seaview Avenue, would like to see the building saved and have free movies in there.

Commissioner Gould indicated that she wanted to take a long hard look and the cost to renovate the building. She added that the dialogue was great and wanted to hear from the public.

Kurt Hastings, President of Wildwood Crest Historical Society, added that the society exists while the museum does not. He would like to see the museum somewhere.

Nancy Pietropaoli, 6002 Seaview Avenue, would like to keep the building.

Mayor Cabrera added that the area is lacking in arts and it should be a public gathering space and it should be kept on the agenda.

Commissioner Gould added that perhaps the Borough should place a poll on the website.

Pam Gentek, 5910 Park Boulevard, added that the Borough needs to utilize existing buildings better and does not want to keep the building without a vision.

Mayor Cabrera wants to continue to talk with Catherine Lorentz and for this to stay on the agenda and that money and vision need to be discussed.

Commissioner Thompson wants bids to go out for repair and the building needs hear and air and wall repaired.

- **-Building Security / Active Shooter-** Work in progress with police.
- **-Bulkhead issue** On hold.
- **-Smoking on Public Beaches** next summer will be banned. We have signage ordered to encourage people to be courteous when smoking near others and to smoke on the back beaches.

Don Fasolo, 222 E. Hollywood Avenue, added that the bill has passed and waiting for a signature. It will allow for 15% designated in certain areas and enforcement was the issue.

**-Permitting One-Day alcohol permits for events-** Commissioner Cabrera would like to have this introduced for the July 11<sup>th</sup> agenda.

#### **NEW BUSINESS:**

#### -Election Day -

The Mayor indicated that since the Borough of Wildwood Crest is non-partisan municipality, he would like to see the Borough provide the meals to the workers. Commissioner Gould is not in favor of this. Mayor Cabrera and Commissioner Thompson are both ok with it since it is a 14-hour day.

#### **PUBLIC COMMENTS:**

The Mayor opened the floor once again for public commentary.

Marie Nickerson, 8801 Bayview Drive, asked about fire pits on the beach. The Administrator brought up concerns of hot coals and the liability issues and how to enforce it. Commissioner Thompson had concerns and advised he will look at the current beach ordinance with regard to fire safety and a process.

Chief Ron Harwood, Volunteer Fire Co. #1, indicated it must be supervised, contained and discharged and cannot openly burn.

Hearing nothing further from the public, Mr. Nick Holland gave a brief description of the upcoming Health & Wellness Fair that will be taking place on June 21, 2018 from 10:00 am to 1:00 pm.
