Kayak Launch/ Sunset Lake Shoreline Stabilization

Yet to be completed by scheduled for the next few days are the railing behind the gazebo, the drinking and filling station, an additional bike rack and the low-level lighting around the circles. All other punch list items will be addressed after our ribbon cutting ceremony which will take place on Friday at 3:00 pm.

Beach/ Dune Project

Representatives of NJDEP Coastal Engineers conducted surveys of our beaches last week. I expect to speak with Chris Constantino to get an update on progress tomorrow.

Rio Grande Avenue Gateway Improvement Project

As many of you have seen, construction on this County project has stopped for the summer for the most part. The cement wall which houses the gas-powered pump station has been constructed and will have a painting of a tram car on it when complete. It will be less visible when the earth berm is constructed about a third of the way up the wall. Construction will commence again in the fall.

Cape May County Open Space and Recreation Applications 2018

Marc DeBlasio is currently preparing the plan and bid specifications for this fall project. Conceptual plans are currently posted on our website and will be updated as soon as Marc completes them.

Center Designation

 - ➤ The Borough has elected to submit for the reconstruction of Beach Avenue from Cresse Avenue to Lotus Road.
 - > The grant application deadline is July 19, 2019.

Capital Projects

- 1. FY2019 NJDCA Small Cities Program
 - The State has notified the Borough that \$354,545.00 in grant funding has been allocated for ADA improvements at the Old Library Building and Von Savage Pool.
 - ➤ Our office provided a proposal to the Borough on June 6, 2019 to complete the proposed improvements.

2 FY 2018 NJDCA Small Cities Program – Rambler Road Beach Street End

- ➤ All work is completed and the project is in the close out phase.
