Gazebo-by-the-Sea (Ocean Avenue and Rambler Rd.)

Set-up: 6:30 a.m.; off street by 9 a.m.

Show: Friday – 9 a.m. to 5 p.m.

Saturday – 9 a.m. to 1 p.m. (optional)

Space Size: maximum 10 feet x 10 feet (**no spikes; sandbags only**)

Cost Per Space – Craft: \$125

CRAFTER DEADLINE: Sept. 5, 2024, or until the 40-vendor limit is reached

NO REFUNDS DUE TO INCLEMENT WEATHER!**

Vendors must provide own power sources as electric is not available. Jewelry vendor space is extremely limited. Jewelry vendors must register ASAP. No more than seven (7) jewelry vendors will be admitted to the show. No parking on premises after setup. Spaces are limited and should be left open for customers. If staying for Day 2, DO NOT leave valuables in tent overnight. Wildwood Crest is not responsible for security.

REQUIREMENTS:

- All craft vendors will be **REQUIRED** to submit proof of insurance with the *Borough of Wildwood Crest* endorsed as an additional insured party, with liability coverage of at least \$1 million. Proof of this insurance must be submitted at time of payment (do **NOT** send separately) and must include the insurance form and the endorsement (insurance documents should be at least **TWO** pages).
- All work **MUST** be homemade or handmade
- Photos of crafts to be exhibited and the **DISPLAY** must be submitted with application
- Breakdown **MAY BEGIN** at 5 p.m. on Friday and 1 p.m. on Saturday (**EARLY BREAKDOWNS ARE NOT PERMITTED! Failure to comply may result in loss of consideration for future shows**).
- Post-dated checks will not be accepted. Make all checks payable to the Borough of Wildwood Crest.
- **Checks received after deadline will be returned.** Note: Absolutely no refunds after 30 days prior to the show!
