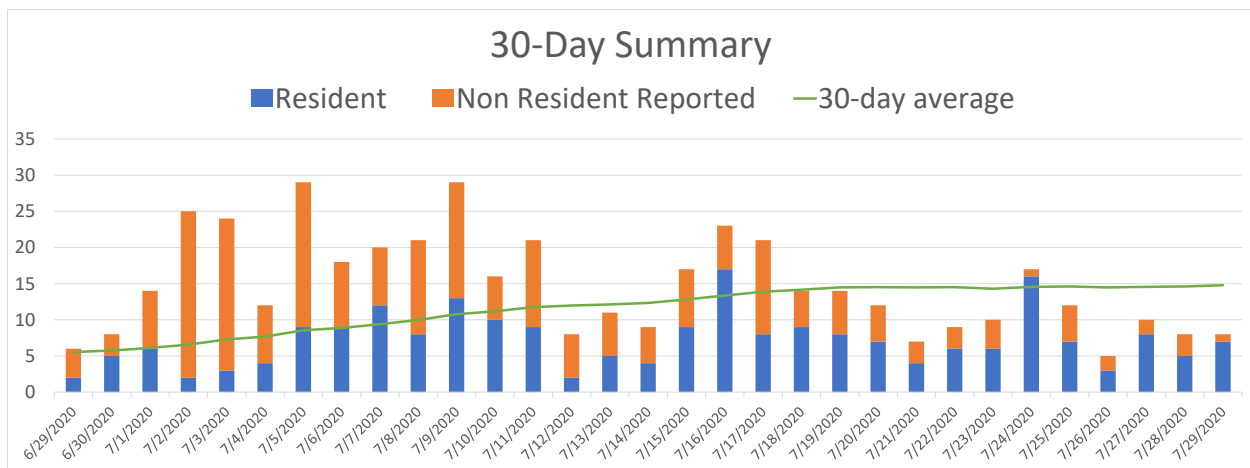

Cape May Court House- New Jersey has 180,766 total COVID-19 positive cases and 13,923 deaths. Total positive cases of COVID-19 infection in Cape May County is now 971 including 81 deaths.
