

WILDWOOD CREST PLANNING BOARD

ORDINANCE NO. 501 (Chapter 39 of the Code of the Borough of Wildwood Crest)

N.J.S.A. 40:55D-23

Code: 50-1

Consists of nine (9) members:

Class 1: Mayor, ex officio

Class 2: One (1) official of the Borough to be appointed by the Mayor

Class 3: Member of Governing Body

Class 4: Other citizens (6) of Borough to be appointed by the Mayor
Members serve without compensation. Class 4 members shall hold no municipal office except one of such members may be a member of the Zoning Board of Adjustment.

Class 1: Corresponds with official term

Class 2: Annually

Class 3: Member of the Governing Body - terminates at conclusion of term of office

Class 4: One (1) member expires the end of each year. Thereafter, appointed for number of years as there are Class 4 members on the Board

NOTE: ALL CLASS 4 MEMBERS ARE APPOINTED FOR A TERM AS LONG AS THERE ARE MEMBERS IN SAID CLASS (4 YEARS EACH)
