- **Section 5:** No person shall retaliate against any person who reports any alleged discrimination, harassment or violation of civil rights, provided however, that any person who reports alleged violations in bad faith shall be subject to appropriate discipline.

Section 6: The Borough Administrator shall establish written procedures that require all officials, employees, appointees and volunteers of the Borough of Wildwood Crest as well as all other entities subject to this resolution to periodically complete training concerning their duties, responsibilities and rights pursuant to this resolution.

COVID-19 UPDATE

The Cape May County Health Department continues to hold regular vaccination clinics throughout Cape May County in various locations. ONGOING AND UPCOMING PROJECTS

Beach End Bump Outs

We have re-submitted our application to Open Spaces to obtain special recreational funding in the amount of \$3.4M for the beach bump outs south of Rambler. The Open Spaces Board is currently reviewing our application. I will report back to you as soon as I receive word from them.

Pacific Avenue

We just received word that the County's contractor has been authorized to proceed with the resurfacing effective October 12th. South State is expected to commence work shortly and proceed until May 13th. The first phase of the project will from Rambler to St. Louis. The second phase of the project will take place in fall of 2022. Pertinent information regarding the County's project will be posted on the Borough's website as we receive it.

Scoop Taylor

This ADA improvement project is really shaping up. The hardscaping improvements and landscaping are now nearing completion. We expect the shelter to arrive in December now due to transportation issues. This project is mostly funded by a FY2020 Small Cities ADA grant.

1. Fiscal Year 2022 NJDOT Municipal Aid Program

- ➤ The NJDOT has announced they are receiving State Aid applications for Roadways, Bikeways, Pedestrian, Safe Streets to Transit and Transit Villages.
- ➤ The Borough has selected the reconstruction of Syracuse Avenue from the beach block to Bayview Avenue. The applications was successfully submitted on June 1, 2021.

2. FEMA Flood Mitigation Assistance (BRIC)

- ➤ The Borough is proposing to construct one (1) bayside storm sewer pump station, install bay outfall SCADA control valves and associated storm sewer improvements in the north west section of the Borough.
- Our office has met with Jim Rutala to develop the application submission, which is due November 30, 2021.

3. Fiscal Year 2022 NJDCA Small Cities Program

- The Borough has decided to submit a grant application for ADA beach access improvements-phase 2 (Louisville Avenue to Toledo Road).
- ➤ Our office successfully provided the supporting engineering report to Mark Blauer on September 2nd.

4. <u>Cape May County Open Space Board – Coastal Recreational Enhancements</u>

- The Borough has decided to submit a grant application for ADA beach access improvements-phase 2 (Orchid Road to Jefferson Avenue).
- ➤ In support of the grant application, our office transmitted the grant application to Cape May County on December 15, 2020.
- > The County has indicated preliminary favorability and requested additional information.
- ➤ The Borough provided a supplemental presentation to the CMCOSB on September 28th and a final decision is anticipated in late October.

Capital Projects

1. <u>Pacific Avenue Storm Sewer Improvements and Borough Street Improvements</u>

- ➤ The bid was awarded to Asphalt Paving Systems in the amount of \$5,767,600.00.
- > The contractor has completed all the work in the original contract and we are in the process of contract closeout.
- The Borough has approved a Change Order for improvements on Washington Avenue and various streets.
- ➤ The Contractor is scheduled to mobilize to Washington Avenue on October 20th.

2. Fiscal Year 2021 NJDCA Small Cities Program

- ➤ The Borough has decided to submit a grant application for ADA beach access improvements-phase 1 (Orchid Road to Toledo Road).
- ➤ On June 22nd, the Borough was notified that a \$400,000.00 grant was allocated for the project.
- > Our office is currently in the design phase and bidding is scheduled for November, 2021.

3. Reconstruction of Beach Avenue and Stanton Road

- The Borough was notified that a grant in the amount of \$155,000.00 was allocated for the reconstruction of Beach Avenue from Crocus Road to Forget-Me-Not Road.
- ➤ The Borough has been notified by the NJDOT that a grant in the amount of \$185,000.00 was allocated for the reconstruction of Stanton Road from the Beach to New Jersey Avenue.
- > The contractor has completed all of the improvements on Stanton Road.
- ➤ The improvements on Beach Avenue are scheduled for the week of October 25th.

4. FY2020 NJDCA Small Cities Grant Application-Scoop Taylor Park

- ➤ The contract was awarded to Command Company, Inc. in the amount of \$257,750.00.
- ➤ The playground and safety surface has been installed.
- The contractor mobilized back to the site the week of September 20th to complete the remaining improvements.
- ➤ All site work will be completed by October 22nd.
- > The remaining item is the installation of the Gazebo (which is currently on back order).

5. Beach Street End Public Access Improvements – Phase 1

- The contract was awarded to Fred M. Schiavone Construction, Inc. in the amount of \$1,250,022.60.
- > The contractor has fully completed Newark Avenue and Trenton Avenue.
- The contractor has remobilized to the Borough to complete the remaining five (5) street ends.
- The majority of the platforms and decking is complete.
- The foot showers have been installed at all locations.

- 6. Fiscal Year 2019 NJDCA Small Cities Program Renovations to the Old Library
 - The project was advertised for public bid on October 13th and the bid opening is scheduled for November 18th at 10:00 AM.
 - ➤ A non-mandatory pre-bid meeting is scheduled for Friday, October 22nd at 11:00 AM at the Old Library site.

IN PARTNERSHIP WITH THE BOROUGH OF WILDWOOD CREST

THE GOAL:

Our goal in Summer 2021 was to inspire our community to take action on the pollution crisis on our beaches. We aim to build more connections & relationships with the individuals & businesses who play a huge role in our summers here in the Crest. By working together, we can create a more sustainable future for not only Wildwood Crest but beaches around the world.

THE SOLUTION:

Our Services

We ran weekly beach cleanups from June 20th - September 4th, every Sunday night, some weeks Saturday or Monday depending on the community's schedule. Our sunset services were a new addition to the Crest this summer, adding another three sweeps to our beaches at night per week. This program lasted throughout the month of July.

New Additions

This summer we added our public cleanup station on Rambler Road the first week of July. This cleanup station was intended to allow beach patrons to take a beach cleanup on by themselves or with friends, a great addition for people who can't participate in our cleanups. Our signs on the back of the porta potties have caught everyone's attention walking to and from the beach, giving them a reminder to pick up after themselves. We were also able to update our equipment this summer which was great & made it a more enjoyable time for volunteers. Last but not least, the NO SMOKING flags, people can see them from far away & the message is clear, smoking is one of the biggest problems we face on our beaches.

THE RESULT:

This year we were able to really stretch our arms when it comes to new volunteers, opportunities, & business relationships. There were a lot of new faces this summer & a lot of our core group from year one still sticking with us. We had people of all ages from little children to adults with grandkids, it truly was an amazing thing to see. The community awareness, support, & involvement has grown a lot this year. One thing we utilized this summer that helped us network more was the Wildwood/Wildwood Crest Facebook groups. The feedback we received in those group chats were overwhelmingly positive & you can see people love what we are doing. From those group chats we gained a lot of new faces & even connected with a few businesses. One of our new partners this summer is Crest Custom Cart Kreations, a local beach cart builder in the area donated two of his beach carts to help assist our cleanups. With some of our cleanups over 300 lbs in trash, we needed them! We were able to talk to businesses about working together in the future, understanding everyone is still recovering from the pandemic. The Sunset Cleaning services were a huge addition to our services & we are so grateful for WCBP allowing us to use their John Deer mules. With this service, we were able to connect with the community better by talking & explaining what we were doing. The best part was we covered the most area in the shortest amount of time. Our beach cleanup stations were loved by the community & we had people asking to install more on different streets on our beaches. We had people visit from out of town, see our cleanup stand, then email us about getting one in their town. (Cape May) These stands made it easier for people to take action on their own & when they couldn't join us in a cleanup. The signs & flags worked out great with getting our message out, with more signage & informationals, people will understand how important the beach is to this community.
