Prior to the vote, Commissioner Gould indicated this project was a mistake and that Wildwood Crest is the only coastal community without beachfront parking. She cited an article about a brass knuckle fight over a parking spot that took place in Wildwood Crest over the summer.

Commissioner Thompson agreed that parking is needed and believes it could be at Sunrise Park on the corner. He further indicated the old library will still have a few spots. He added the borough has spent approximately \$200,000 on roof and architect and that the building will get use. If it were a parking lot, it would be used 6-8 weeks a year. He added the building is sound and it will be great for a senior center and that tourism can be moved to that location. In addition, he added that Crest Pier is not an option in the summer due to the Crest Pier playmates camp. Lastly, Commissioner Thompson added that parking meters are not used until the height of the summer.

Mayor Cabrera thanked the current governing body members for 4 years of service. Over the course of the past four years, there have been many presentations and points made regarding this project:

- 1. the building is historic; it was donated to the Borough in the 1970s and the lot was created through accretion and it should be preserved.
- 2.there is parking on the south side of the building and even the Chief advised that people are not using the metered parking there and park on the side streets.
- 3. the JIF claim covered the wind damage to the north side of the building
- 4. the borough received a \$260,000 grant for ADA accessible bathrooms and the building will house retail, there will be parking, it can be rented for weddings, it can house Wildwood Crest historical artifacts and that there will be a "nature / environmental / art flavor" to the building.
