- 2. A one-year (2024) contract, with two one-year options and a thirty-day cancellation provision, for On-Site Lead Based Paint Inspection is awarded to LEW Environmental Services with fees detailed in the proposal.

- 3. The Borough of Wildwood Crest authorizes the Mayor and the Borough Clerk to enter into the aforesaid contract with LEW Environmental Services to provide on-Site Lead Based Paint Inspection services.
- 4. The aforementioned agreement provides for extensions from year-to-year by mutual agreement and resolution, with the last renewal to expire no later than December 31, 2026.

RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE BOROUGH OF WILDWOOD CREST APPROVING ANNUAL SEWER RATES AND MINIMUM CHARGES FOR CALENDAR YEAR 2024

WHEREAS, Borough of Wildwood Crest Ordinance Number 1330 contain formulas for the calculation and establishment of annual sewerage rates, including the current year Variable Rate Fee; and

WHEREAS, the said calculations have been prepared and reviewed in accordance with the aforementioned Ordinance Numbered 1330; and

WHEREAS, it is promulgated in Ordinance No. 1330 the Commissioner of Revenue and Finance shall submit the proposed sewerage rates and minimum charges to the Board of Commissioners for confirmation by resolution; and

WHEREAS, the rates as calculated, reviewed and submitted are as follows:

Fixed Rate Charge: \$5.00 per 1000 gallons of metered water consumption Variable Rate Charge: \$24.00 per 1000 gallons of metered water consumption

Minimum Annual Charge: \$124.00
