ONGOING AND UPCOMING PROJECTS

Beach End Bump Outs

Decks are complete. The contractor is waiting on some benches for installation and will be back to complete road work in the fall all 11 street ends south of Rambler.

Crest Arts Pavilion

The interior project is now complete. Hours of operation are 9:00 am to 3:30 pm Monday through Saturday and 9:00 am to 1:00 pm on Sunday. The café was successfully leased and the vendor is doing great as is the Crest merchandise store.

Hereford Inlet to Cape May Inlet Beach and Dune Construction

Nothing new to report

New Jersey Avenue

The County's reconstruction of New Jersey Avenue is expected to commence in the spring of 2025. This project is expected to take two years. The county's striping plan has been approved by resolution and they are in the process of re-initiating the traffic synchronization since they now have clear direction of the proposed road diet alignment of the mainline. The County's traffic consultant can now formalize the revisions to the proposed traffic signals so that the road diet improvements and the separate traffic signal project can be properly coordinated. We now need to

provide the county with the dimensioned layout / geometry of the two proposed parking areas that will be situated between Cardinal and Aster roads along the easterly side of the project. We are working on that layout now.

Sunset Lake- State Channel Dredging

The NJDOT Office of Maritime Resources will be dredging State boating channels in North Wildwood, Wildwood and West Wildwood from the mouth of Beach Creek to Post Creek Basin between the beginning of September to the end of January, 2023 to remove shoals and restore navigability. Approximately 124,000 CY of sediment will be removed using a hydraulic cutterhead pipeline dredge and pumped to one of three sites for dewatering. Dredging operations will take place 24/7 during this timeframe. The three sites identified for dewatering are 401/501 W 26th Avenue in North Wildwood, 510 NY Avenue in North Wildwood and 525 W Spicer Avenue in Wildwood. Once dewatered, the material will be removed from the site and trucked to the Tuckahoe Turf Farm in Atlantic County for use as agricultural soil. Trucking operations will begin on or about February 1 and will be completed on or about May 31, 2024 and will follow main routes to and from the sites in accordance with municipal and county approved trucking routes. As of last Friday, we were informed that NJDOT is having difficulties with DEP permitting. I will keep everyone up to date as I receive information.

CAFRA Applications

Nothing to report at this time.

Washington Avenue BRIC Planning Study

DeBlasio and Associates has competed the study of the Washington Avenue flooding issues. This was funded by a \$70,875 FEMA grant. The borough's contribution of \$70,875 was \$23,625. We are now getting ready to file an application for work that has been recommended in his study.

EV Charging Stations

Nothing new to report

FY2023 DCA-Small Cities ADA Grant

As previously reported, our FY2023 DCA Small Cities Grant application was approved in the amount of \$342,720. These funds will be used to renovate the 3 bathrooms in the municipal building and 3 bathrooms at the Crest Pier. Marc is currently working on plans with our architect.

Plan Endorsement

I happy to report that our petition for plan endorsement was approved unanimously by the State's Planning Commission last week. We now have a smaller town center but are endorsed for the next 10 years.

ENGINEER'S REPORT:

Capital Projects

- 1. Pacific Avenue Storm Sewer Improvements and Borough Street Improvements
 - ➤ The bid was awarded to Asphalt Paving Systems in the amount of \$5,767,600.00.
 - ➤ All work on Cardinal Avenue has been completed and we are in the project close out phase.
- 2. FY 2023 NJDOT Municipal Aid Program Reconstruction of Orchid Road
 - ➤ The Borough has been allotted a \$170,085.00 grant from the NJDOT.
 - > Our office has been authorized by the Borough and we are in the design phase.
- 3. Washington Avenue Storm Sewer Outfall Preliminary Investigation
 - ➤ The final report is scheduled to be finalized and completed by July 21st.
- 4. Fiscal Year 2022 NJDOT Municipal Aid Program Reconstruction of Syracuse Avenue
 - > The Borough was notified by the NJDOT that \$196,025.00 was allocated for the Reconstruction of Syracuse Avenue.
 - ➤ The bid opening occurred on October 19, 2022 and the apparent low bidder was Asphalt Paving Systems, Inc. in the amount of \$2,193,300.00.
 - ➤ All work on Syracuse Avenue is completed.
 - > Bayview Avenue has been completed.
 - ➤ The improvements at Preston Park have been completed and the project is nearing completion.
- 5. <u>Beach Patrol Headquarter Renovations-Readvertised</u>
 - The project was re-advertised for public bid on March 1, 2023 and the apparent low bidder was Straga Brothers in the amount of \$2,054,334.00 for the Base Bid plus Alternate Bid 1 and Alternate Bid 2.
 - The contractor has remobilized to the site to finish the demolition.
- 6. Beach Street End Public Access Improvements Phase 2
 - The bid opening occurred on February 1, 2023, and the apparent low bidder was Fred M. Schiavone Construction, Inc. in the amount of \$3,228,065.20.
 - ➤ All eleven (11) street end decking, ramps and railings have been installed.
 - All water main extensions, water services and trench repairs have been completed.
 - > The pergolas have been delivered and installed.
- 7. Von Savage Pool Pool and Roof Repairs
 - The bid opening occurred on March 9, 2023 and the apparent low bidder was Capri Construction in the amount of \$1,267,500.00.

A pre-construction meeting was held on March 30th and construction is scheduled to begin on August 15, 2023.

8. Public Works Roof Repairs

Our office has completed bid documents and will be bidding the project in the near future.

9. <u>Bayside Bulkhead Replacement and Flood Mitigation Improvements</u>

- ➤ The Borough wants to replace or elevate the eleven (11) existing bayside street end bulkheads from Cardinal Road to Primrose Road and implement flood mitigation improvements along the bayside from Cresse Avenue to Rambler Road. It is our understanding that the Borough would like to complete the improvements in a phased manner and initiate the first phase of the bulkhead replacements in the Fall 2023 with construction completed by Spring 2024.
- ➤ Our office has completed the survey of the bayside street ends and are currently in the base mapping and permitting phase.
- > The NJDEP has indicated that a Waterfront Development Permit is required and a CAFRA permit is not required.

CORRESPONDENCE: ATLANTIC CITY ELECTRIC – COMMISSIONER RESPONSE From Atlantic City Electric

Atlantic City Electric appreciates everyone's patience during this Lake Ave substation fire and truly appreciate your kind words about the hard work all of our employees provided over the weekend. Although we are still investigating the cause of the fire, I have provided a brief overview of the summary of the events.

- Atlantic City Electric experienced a fire at the company's Lake Avenue substation in Wildwood, NJ.
- The fire occurred at approximately noon, Friday, July 7, 2023.
- The fire was contained shortly after 1 p.m. on Friday, and the cause of the fire is currently being investigated.
- The safety of our customers, the community, emergency responders and our employees is always most important.
- The substation was deenergized upon arrival of Atlantic City Electric crews, which impacted electric service to approximately 24,000 customers in the Wildwood, Wildwood Crest, North Wildwood, West Wildwood and Lower Township areas.
- As of 4:24 a.m. Sunday, July 9, service has been restored for all customers.
- With respect to the restoration timeline:
 - o We restored 15,000 customers by 10 p.m. on Friday, July 7, within 9 hours of the start of the event.
 - o An additional 2,000 customers by 5 a.m. on Saturday, July 8.
 - \circ $\;$ An additional 3,500 customers were restored by 3 a.m., Sunday, July 9.
 - Between 5 a.m. Saturday and 3 a.m. Sunday, we were performing construction work necessary to be able to use non-damaged equipment at the substation and reintroducing service, via complex switching, to customers via a temporary configuration, while also constructing new equipment to restore remaining customers that resulted in equipment issues due to customer demand.
 - o The remaining 3,500 customers were restored by 4:24 a.m., Sunday, July 9.
- We know this has been a challenging event for our customers and we thank them for their patience and understanding as we worked to restore service. We also thank our crews, operations teams and all the support personnel, including our contractors, who assisted in this effort. We also thank our municipal officials, our local first responders, and our public works members for their assistance in our restoration effort.

The governing body thanked the Police, Public Works, EMS, Volunteer Fire Co and the Beach Patrol. Everyone worked seamlessly.

Commissioner Schiff – He noted that the Borough of Wildwood Crest had No Recommendations at the end of the audit and job well done. He thanked everyone. Secondly, he thanked Crest Savings Bank for providing lunch to first responders.

Mayor Cabrera – He agreed with all of the previous comments. He thanked the CFO and department heads. He noted that during the power outage, many of the residents and visitors were very courteous. He reminded everyone that there was a food truck event and concert at Centennial Park.

Commissioner Franco added that Mayor Cabrera did a great job during the power outage.

Hearing nothing further from the public, Mr. Schiff motioned and Mr. Franco seconded that the meeting be adjourned. All were in favor. The time was 5:42 p.m.
