ADMINISTRATOR'S REPORT:

September 20, 2023

Beach End Bump Outs

Asphalt and concrete work will be commencing at some of the 11 street ends south of Rambler in two weeks. They are: Toledo, St. Paul, Monterey, Miami, Louisville, Nashville, Atlanta, Farragut, Stanton, Stockton, and Orchid. That will be the final phase of this project. We will be submitting an application for reimbursement for all Open Spaces work shortly.

Crest Arts Pavilion

Th public hearing for our \$1.043 million Open Spaces funding for the Crest Arts Pavilion is now scheduled for September 26th. I will attend the County Commissioner's meeting to answer any questions.

Hereford Inlet to Cape May Inlet Beach and Dune Construction

All three municipalities have signed their respective state aid agreements. We have the 65% plans here for review and comment. The only change that I observed is to the Cresse Avenue vehicle crossover. It is wider and flatter to accommodate large trucks. All indications are that this project will take place between 18-24 months from now. The borough has no cost-share for this coastal storm protection project.

New Jersey Avenue

The County's reconstruction of New Jersey Avenue is expected to commence in the spring of 2025. This project is expected to take two years. The county's striping plan has been approved by resolution and they are in the process of re-initiating the traffic synchronization since they now have clear direction of the proposed road diet alignment of the mainline. The County's traffic consultant can now formalize the revisions to the proposed traffic signals so that the road diet improvements and the separate traffic signal project can be properly coordinated. We now need to provide the county with the dimensioned layout / geometry of the two proposed parking areas that will be situated between Cardinal and Aster roads along the easterly side of the project. We are working on that layout now.

Sunset Lake- State Channel Dredging

The NJDOT Office of Maritime Resources has awarded the contract for Phase I of the State's channel dredging project to Mobile Dredging who will be dredging State boating channels throughout the Wildwoods as a two-phased project. The first phase of this project encompasses the state channels in North Wildwood, Wildwood and West Wildwood from the mouth of Beach Creek to Post Creek Basin remove shoals and restore navigability. This 1st phase is expected to commence in October and involves the removal of approximately 124,000 CY of sediment from the channels using a hydraulic cutterhead pipeline dredge and pumped to one of three sites for dewatering. Dredging operations will take place 24/7 during this timeframe. The plan includes three sites identified for dewatering are 401/501 W 26th Avenue in North Wildwood, 510 NY Avenue in North Wildwood and 525 W Spicer Avenue in Wildwood. Once dewatered, the material will be removed from the site and trucked to the Tuckahoe Turf Farm in Atlantic County for use as agricultural soil. It is expected that trucking operations will begin on or about February 1 and will be completed on or about May 31, 2024, and will follow main routes to and from the sites in accordance with municipal and county approved trucking routes. I will provide an update once DOT opens the bids on Thursday. We expect Wildwood Crest's phase of the project to go out to bid next year after property acquisitions take place,

CAFRA Applications

We just received word from our environmental consultant that a permit is not needed for the installation of a camera with pole at Sunrise Park.

Washington Avenue BRIC Planning Study

Now that the planning study is completed, we are working with our grant writer to develop a FEMA application for this flood mitigation project. The applications are due in November. 70% of the FEMA grants awarded in NJ in 2022 were for clients of our grant writer. He has a strong track record with FEMA.

EV Charging Stations

The State has approved the Crest Arts Pavilion location (6301 Ocean Avenue) for two EV fast charging stations. I believe this will provide \$75,000 each but this will be confirmed once they provide the grant agreement which we should receive soon.

FY2023 DCA-Small Cities ADA Grant

As previously reported, our FY2023 DCA Small Cities Grant application was approved in the amount of \$342,720. These funds will be used to renovate the 3 bathrooms in the municipal building. We have met with our architect who is working with DeBlasio & Associates on plans and bid documents.

ENGINEER'S REPORT:

Capital Projects

- 1. FY 2023 NJDOT Municipal Aid Program Reconstruction of Orchid Road
 - The Borough has been allotted a \$170,085.00 grant from the NJDOT.
 - Our office has been authorized to add the sanitary sewer replacement of Wisteria Road from New Jersey to Park Boulevard to this project.
 - The project is scheduled to be advertised for public bid the week of October 9th.

2. Fiscal Year 2022 NJDOT Municipal Aid Program – Reconstruction of Syracuse Avenue

- > The Borough was notified by the NJDOT that \$196,025.00 was allocated for the Reconstruction of Syracuse Avenue.
- All work has been completed and the project is entering the close out phase.

3. <u>Beach Patrol Headquarter Renovations-Readvertised</u>

- The project was re-advertised for public bid on March 1, 2023 and the apparent low bidder was Straga Brothers in the amount of \$2,054,334.00 for the Base Bid plus Alternate Bid 1 and Alternate Bid 2.
- ➤ The contractor has remobilized to the site and completed demolition. The foundation work is underway and nearly completed.

4. <u>Beach Street End Public Access Improvements – Phase 2</u>

- The bid opening occurred on February 1, 2023, and the apparent low bidder was Fred M. Schiavone Construction, Inc. in the amount of \$3,228,065.20.
- The final roadway and sidewalk restorations will be completed the week of October 2nd.
- ➤ The Borough has requested a change order to install additional street end bollards.

5. Von Savage Pool – Pool and Roof Repairs

- The bid opening occurred on March 9, 2023 and the apparent low bidder was Capri Construction in the amount of \$1,267,500.00.
- A pre-construction meeting was held on March 30th and construction began the week of August 15, 2023
- > The roof repairs are complete and the contractor is working on the pool improvements.

6. Public Works Roof Repairs

Our office has completed the design of the Public Works Roof. The project is going to be combined with the Crest Pier Roof Replacement being designed by another Engineer. The project will be completed via the State Co-operative Program.

7. Bayside Bulkhead Replacement and Flood Mitigation Improvements

- ➤ The Borough wants to replace or elevate the eleven (11) existing bayside street end bulkheads from Cardinal Road to Primrose Road and implement flood mitigation improvements along the bayside from Cresse Avenue to Rambler Road. It is our understanding that the Borough would like to complete the improvements in a phased manner and initiate the first phase of the bulkhead replacements in the Fall 2023 with construction completed by Spring 2024.
- The first phase of bulkhead replacements is scheduled for public bidding the week of October 23rd.

8. <u>Crest Arts Pavilion Site Improvements</u>

The project is currently in the design phase and is scheduled for public bidding in November 2023.

CORRESPONDENCE:

- 1. Mayor Cabrera indicated that the Crest assisted with a recent Junior triathlon that had 43 participants from grades 6-12 and it was overwhelmingly successful. He anticipates that this will be a yearly event.
- 2. The Mayor and Connie met with representatives from Atlantic City Electric (Doug Mokoid, Kristen McEvoy and Ronnie Town) to discuss the power outage of July 7, 2023 and subsequent outages. Here are the takeaways:
 - There is no capacity issue with service in the Wildwoods.
 - The Investigation of the fire is ongoing.
 - Preliminary investigation shows that the fire started in an underground wire surrounded by conduit. The fire then spread to the substation.
 - This is an isolated inciden.t
 - Remedial action is taking place to isolate the underground wire in the case of another fire and a fire suppression system will be installed.
 - The most recent 2 outages are unrelated the fire.
 - ACE is working on improving communications with ratepayers and municipalities.
 - A daily team has been assigned to the Wildwoods to update business owners and officials.
 - No claims have been answered as the investigation is ongoing.
 - Equipment failure is likely the cause therefor the tariff is regulated by the Board of Public Utilities.

PUBLIC COMMENTARY:

Al Catarro, flooding on Seaview & Aster has been substantial. The Mayor added that Public Works has reviewed the catch basins and they are clean. Next up will be video surveillance of the lines.

Karen Nagle, added that the pitch in the road on Seaview appears to be graded so it drains to her side. The Mayor indicated the road was redone in 2011-12 and that the Engineer would check it out.

Mike Marino, on the telephone, thanked the governing body for taking action to calm the traffic in his neighborhood. He notes that infrastructure in this country is failing and Wildwood Crest should be commended for being proactive.

NEW BUSINESS:

-Potential Swim / Run Event -The Mayor recapped that in 2022, the Crest hosted two events: Crest Best Run Fest and a Crest Best Swim. There have been several requests from the athletic community to bring back the events and he has reached out to several race directors and timing companies. The TDC was also made aware of the recent requests. The Mayor added there are hopes to bring it back with similar dates as the previous races.

OLD BUSINESS:

- -Crest Pier capital planning for generators- In queue.
- **-Traffic Calming** The commissioners are in receipt of plans for review. They are waiting for the anticipated traffic study proposal from a Traffic Engineer.
- -Code Enforcement Personnel- No movement. Looking to address in 2024 for help with weekend hours.
- -Back Beach Excavation: On hold until US Army Corps of Engineers embarks on the dune.
- **-Dredging:** The Administrator's report covered this.
- **-NJ Avenue infrastructure pre-county:** The Engineer is working on for 2025 Plan.
- -PW roof: Waiting to go out to bid...in conjunction with Crest Pier coop.
- **-Bayside outfalls and capacity / bulkhead repairs / replacement**: Engineer touched on this 5 street ends- raising bulkheads and tide flex valves, etc.
- -Arts Pavilion Exterior with CMCOS: Administrator touched on it.
- -Washington / Seaview beach outfalls and capacity: The Engineering report is complete and now it is with Jim Rutala to apply for funding.
- **-Update Landscaping and add lighting in Business district -NJ** Planters are on order...hopefully installed by May.
- **Lightning Detection System:** According to Mr. Schiff, once the beach patrol headquarters are underway, he will come back with a recommendation.

PUBLIC COMMENTARY:

Frances West added that she saw a surveyor on Buttercup and they discussed the flooding issue that comes from the bay and that something she called "flappers" were not working properly. The Mayor added that this what they discussed previously and that it will be a 2-3 year project depending on funding. They would like to replace the valves so they can be manually closed and there will be raising of bulkheads after an ordinance is passed to require homeowners to raise their bulkheads.

COMMISSIONERS COMMENTS:

Mayor Cabrera indicated that this weekend is Seafarer's Weekend and our last official event of the season. Due to deteriorating weather conditions, the fireworks display has been cancelled. A decision will be made later on the vendors and events for Saturday.

Commissioner Franco: Due to closed sessions, commissioner comments were unable to be voiced. With that said, Mr. Franco wanted to extend his deepest condolences to the family of Robert Patterson. He served on the GWTIDA board and TDC and he will be missed.

Commissioner Schiff: No Comment.

Hearing nothing further from the public, Mr. Schiff motioned and Mr. Franco seconded that the meeting be adjourned. All were in favor. The time was 10:01 a.m.
