# Capital Projects

- 1. <u>Bayside Bulkhead Replacement and Flood Mitigation Improvements</u>
- The contractor has completed all of the underground storm sewer system piping and has completed the bulkhead installation at Primrose, Myrtle, Lotus, Fern, Forget me Not, Columbine, Sweetbriar Road and Cardinal Road.
- Concrete work and base paving were completed on the above streets. The contractor demobilized on June 13<sup>th</sup> per the contract and plans to return to complete the work starting September 2<sup>nd</sup>.
- 2. FY2023 NJDCA Small Cities Program-Municipal Building Bathroom Improvements
- The bid opening occurred on October 30, 2024, and the lowest responsible bidder was Capri Construction Company in the amount of \$270,549.00.
- All work is complete and it is in the closeout phase.
- 3. FY 2024 NJDOT Municipal Aid Program-Reconstruction of Toledo Avenue

- > The bid opening occurred on October 30, 2024, and the apparent low bidder was Asphalt Paving Systems, Inc in the amount of \$2,174,400.00.
- ➤ The contractor has completed the project and are currently working on final restoration.

#### 4. 2025 Road Resurfacing Program

- ➤ The bid opening occurred on April 23, 2025 and the apparent low bidder was South State, Inc. in the amount of \$154,202.40.
- A preconstruction meeting was held on May 7, 2025 and the contractor completed the paving work and roadway striping. The project is in the closeout phase.

#### 5. NJ IBank (NJIB) – Sanitary Sewer and Roadway Improvements

- The NJIB advised the Borough that approximately \$3,000,000.00 in grant forgiveness is available along with grant funding for engineering services.
- ➤ Our office received authorization to advertise from the NJIB and the project was advertised for public bidding on May 21, 2025 with an expected bid opening on June 24, 2025.
- ➤ The bid opening occurred on June 24, 2025 and the apparent low bidder is Charles Marandino, LLC in the amount of \$2,573,600.00.

#### **Grant Applications**

#### 1. FEMA Flood Mitigation Assistance (BRIC) & (HMA)

- > The Borough is proposing to submit to FEMA BRIC for two (2) bayside storm sewer pump stations and associated storm sewer improvements in the northwest section of the Borough.
- > The Borough is proposing to submit to FEMA HMA for the Washington Avenue storm sewer improvements as outlined in the recently completed study.
- **>** Both grant applications have secured initial selection from FEMA.
- Additional information was provided to NJOEM on November 14<sup>th</sup>.

#### 2. FY 2024 NJDCA Boardwalk Preservation Fund

- The Borough has selected to submit the Reconstruction of the Heather Road fishing pier.
- ➤ The grant application requests \$3,600,000.00 for the replacement and extension of the fishing pier including ADA accessible walkways, fishing nodes and pavilion.
- ➤ The Borough was notified by NJDCA that a \$1,087,425.00 grant was allocated for the project.

#### 3. Federal Funding Grant Opportunity-Congressman Van Drew – FY2024

- > Our office has been in contact with Congressman Jeff Van Drew's office to discuss federal funding opportunities for Borough capital projects.
- ➤ On December 28, 2023, our office submitted a funding request for bayside flood mitigation improvements.
- On March 12<sup>th</sup>, our office and the Borough met with representatives of Congressman Van Drew's office and were informed that the project was selected for special funding consideration.

# 4. FY2025 NJDOT Municipal Aid Program

- ➤ The NJDOT is accepting grant applications for Bikeway, Pedestrian and Roadway Improvement Projects. The application deadline is July 1, 2024.
- > Our office has been authorized by the Borough to submit the Reconstruction of Stockton Road as the grant application.
- ➤ The grant application was submitted on May 28, 2024.
- ➤ The Borough was notified that a \$158,190.00 grant was allocated for this project.

#### 5. FY2024 NJDCA Small Cities Program – Crest Pier Bathroom Improvements

Mike Baker commended the borough on Wildwood Crest and what a great place it is to live. Mr. Baker voiced his concerns over an eye sore house on the corners of Rambler and New Jersey Avenues. It was made known that code officials are very much aware of the property and that it is in the hands of the court. The Solicitor indicated it is a lengthy process and they pay fines and once the property maintenance violations are again given, they will have to go to court again until they comply. The mayor added he would inquire about the status with our shared court and code officials and get back to Mr. Baker.

Jennifer Hradish showed the governing body pictures of two properties adjacent to her home where there are overgrown shrubs and an abundance of mosquitos and open trash. She indicated the Mosquito Commission was there back in April or May and they indicated they would be in touch with the Board of Health and there doesn't appear to be a change in the status of the mosquitoes. The Solicitor indicated it appears to be a maintenance issue and advised Ms. Hradish to contact Code Enforcement. Capt. D'Amico added that he recently had a conversation with Code Enforcement and they are working to remediate and he will take the pictures and will communicate that with Code Enforcement.
