**WHEREAS**, pursuant to <u>N.J.S.A.</u> 39:4-14.16, electric bicycles and electric scooters are permitted to be operated on the streets, highways, roadways, and bicycle paths of this State; and

WHEREAS, the Borough of Wildwood Crest, and municipalities throughout the State of New Jersey, have experienced a marked increase in the operation of electric bicycles and scooters on public streets, sidewalks, bike paths, boardwalks, and other shared public spaces, often in close proximity to pedestrians, children, seniors, and motor vehicles; and

WHEREAS, while electric bicycles and scooters offer environmentally friendly and cost-effective modes of transportation, their rapid acceleration, higher maximum speeds, and nearly silent operation can present significant safety risks, including collisions with pedestrians and motor vehicles, loss of rider control, and a heightened risk of serious injury in connection with accidents in general; and

WHEREAS, the Wildwood Crest Police Department, along with law enforcement agencies throughout the State, has reported difficulties in achieving consistent enforcement due to the absence of uniform statewide regulations governing the operation, minimum age limits, helmet use, insurance requirements, licensing, equipment safety, permitted areas of operation, and enforcement procedures, thereby creating inconsistent rules and potential safety risks across municipalities; and

WHEREAS, the establishment of clear, consistent, and enforceable statewide regulations would help ensure the safe and responsible operation of electric bicycles and scooters, while still promoting their use as an alternative means of transportation; and

**WHEREAS**, the Board of Commissioners of the Borough of Wildwood Crest believes that statewide legislation should, at a minimum, address:

- 1) Minimum age requirements for operation;
- 2) Maximum allowable speeds for different classifications of electric bicycles and scooters;
- 3) Rules governing operation on sidewalks, bike lanes, and roadways;
- 4) Equipment safety standards including lights, reflectors, and braking systems;
- 5) Enforcement authority for local police departments; and
- 6) Penalties for violations to promote compliance and accountability.

**WHEREAS**, the Board of Commissioners of the Borough of Wildwood Crest further recognizes the need for public education programs to ensure that riders and the general public are aware of their rights, responsibilities, and the potential hazards associated with these devices;

WHEREAS, the Borough of Wildwood Crest acknowledges and is committed to a cash match; and

**WHEREAS**, the Borough of Wildwood Crest acknowledges and is committed to long-term maintenance of Wildwood Crest Fishing Pier Replacement and Expansion; and

WHEREAS, the Borough of Wildwood Crest confirms the funding category of 2B and the Borough of Wildwood Crest plans to use the Open Spaces Creative Placemaking Plan in the design of the facility; and

WHEREAS, the Board of Commissioners recognize the value of safe public access in Cape May County and the potential to enhance tourism and economic development while also promoting usage of the beachfront amenities with the Fishing Pier Replacement and Expansion; and

**WHEREAS**, the Board of Commissioners desire to apply to the Cape May County Open Space Board for Wildwood Crest Fishing Pier Replacement and Expansion funding for the purposes stated herein; and

WHEREAS, the Total Grant Request is: \$ 2,500,000.00.

## Capital Projects

- 1. Bayside Bulkhead Replacement and Flood Mitigation Improvements
- The contractor has completed all of the underground storm sewer system piping and has completed the bulkhead installation at Primrose, Myrtle, Lotus, Fern, Forget-Me-Not, Columbine, Sweetbriar Road and Cardinal Road
- Concrete work and base paving were completed on the above streets. The contractor demobilized on June 13<sup>th</sup> per the contract, and plans to return to complete the work starting September 2<sup>nd</sup>.
- 2. FY2023 NJDCA Small Cities Program-Municipal Building Bathroom Improvements
- The bid opening occurred on October 30, 2024, and the lowest responsible bidder was Capri Construction Company in the amount of \$270,549.00.
- All work is complete and it is in the closeout phase.

## 3. FY 2024 NJDOT Municipal Aid Program-Reconstruction of Toledo Avenue

- ➤ The bid opening occurred on October 30, 2024, and the apparent low bidder was Asphalt Paving Systems, Inc in the amount of \$2,174,400.00.
- All work is complete and it is in the closeout phase.

## 4. 2025 Road Resurfacing Program

- ➤ The bid opening occurred on April 23, 2025 and the apparent low bidder was South State, Inc. in the amount of \$154,202.40.
- A preconstruction meeting was held on May 7, 2025 and the contractor completed the paving work and roadway striping. The project is in the closeout phase.

## 5. NJ IBank (NJIB) – Sanitary Sewer and Roadway Improvements

- > The NJIB advised the Borough that approximately \$3,000,000.00 in grant forgiveness is available along with grant funding for engineering services.
- ➤ The bid opening occurred on June 24, 2025 and the apparent low bidder is Charles Marandino, LLC in the amount of \$2,573,600.00. The preconstruction meeting was held on July 24<sup>th</sup> and construction will begin on September 2<sup>nd</sup>.

#### 6. New Jersey Avenue Sanitary Sewer and Water Main Improvements

➤ The bid opening occurred on July 23, 2025 and the lowest responsible bidder is Asphalt Paving Systems, Inc in the amount of \$3,345,500.00. Please note that this project contains Wildwood Water Utility participating items in the amount of \$1,051,126.50 and Borough participating items in the amount of \$2,294,373.50.

#### **Grant Applications**

- 1. FEMA Flood Mitigation Assistance (BRIC) & (HMA)
- The Borough is proposing to submit to FEMA BRIC for two (2) bayside storm sewer pump stations and associated storm sewer improvements in the northwest section of the Borough.
- > The Borough is proposing to submit to FEMA HMA for the Washington Avenue storm sewer improvements as outlined in the recently completed study.
- > Both grant applications have secured initial selection from FEMA.
- Additional information was provided to NJOEM on November 14<sup>th</sup>.

#### 2. FY 2024 NJDCA Boardwalk Preservation Fund

- ➤ The Borough has selected to submit the Reconstruction of the Heather Road fishing pier.
- ➤ The grant application requests \$3,600,000.00 for the replacement and extension of the fishing pier including ADA accessible walkways, fishing nodes and pavilion.
- The Borough was notified by NJDCA that a \$1,087,425.00 grant was allocated for the project.

#### 3. Federal Funding Grant Opportunity-Congressman Van Drew – FY2024

- Our office has been in contact with Congressman Jeff Van Drew's office to discuss federal funding opportunities for Borough capital projects.
- ➤ On December 28, 2023, our office submitted a funding request for bayside flood mitigation improvements.
- > On March 12<sup>th</sup>, our office and the Borough met with representatives of Congressman Van Drew's office and were informed that the project was selected for special funding consideration.

#### 4. FY2025 NJDOT Municipal Aid Program

- The NJDOT is accepting grant applications for Bikeway, Pedestrian and Roadway Improvement Projects. The application deadline is July 1, 2024.
- > Our office has been authorized by the Borough to submit the Reconstruction of Stockton Road as the grant application.
- ➤ The grant application was submitted on May 28, 2024.
- > The Borough was notified that a \$158,190.00 grant was allocated for this project.

## 5. FY2024 NJDCA Small Cities Program – Crest Pier Bathroom Improvements

➤ The Borough was notified that a \$400,000.00 grant was allocated by the New Jersey Department of Community Affairs for Crest Pier ADA Bathroom Improvements.

## 6. Cape May County Open Space Board (CMCOSB) Application – Crest Fishing Pier

- Our office was authorized on May 14, 2025 to prepare and submit a grant application to the CMCOSB.
- We are currently working on the grant application.

## 7. Federal Funding Grant Opportunity – Congressman Van Drew – FY2025

- > Our office has been in contact with Congressman Jeff Van Drew's office to discuss federal funding opportunities for Borough capital projects.
- > On March 13, 2025, our office submitted a funding request for Crest Fishing Pier Reconstruction.

- ➤ The NJDOT is accepting grant applications for Bikeway, Pedestrian and Roadway Improvement Projects. The application deadline is June 30, 2025.
- Our office was authorized by the Borough to submit the Reconstruction of Denver Avenue as the grant application.
- > The application was submitted to the State on June 12, 2025.

Lisa Rippo asked about the Ocean Holiday property and for an update. The Mayor indicated at the last meeting that it was in litigation due to an appeal and it is up to the courts. Ms. Rippo then mentioned that she wanted clarification for the resolution with OPRA requests for police records and she was told that starting September 1<sup>st</sup> all police related OPRA requests will go directly to the Chief. The Clerk clarified that many municipalities are doing this and regardless if there is a conflict, all police related OPRA requests will be directed over there. Ms. Rippo then referenced a lawsuit the borough currently has.

Dave McWilliams had several comments:

- 1. E Bikes -Capt. D'Amico indicated that electric bikes are regulated like regular bicycles and there needs to be a change at the state level. He further added that the borough currently has an ordinance in effect that prohibits e bikes on our bike path and there are signs on the bike path.
- 2. Fishing Pier He asked for clarification on scope and price. The Mayor explained the borough owns the Fishing pier and it is need of repair and they would like to see it extended so it is over the water...rough estimate today comes in around 6 million (1.1 million from state boardwalk preservation fund; 2.5 million hopefully from Open Space)
- 3. Dunes the lawsuit of NWW v WC is still pending (no date set) and the Army Corp gave the DEP until the end of August to convey real estate rights to proceed with the project or they may opt out.
- 4. Vegetation at the house adjacent to Mr. McWilliams he thanked the borough for all of the efforts put forth cleaning up the property...he indicated there are still multiple containers in the back yard and he was told that the borough is going back one more time.
- 5. Change of dates for meetings Mr. McWilliams requested that if we need to move meeting dates that we do on a Thursday. The Clerk indicated it was changed at the beginning of August so she could move her daughter into college.

Fred Mettler asked about the 250<sup>th</sup> committee and he was told if he wanted to join, send a letter of interest to the Clerk. He suggested that July 4, 2026 falls on a Saturday and he thinks people would love to see fireworks on the bay. They could be launched from a barge.

Commissioner Schiff extended thanks to the Police, EMS, Public Safety, Beach Patrol, Public Works for all of their efforts during and after the recent storm.


