WHEREAS, the Borough of Wildwood Crest has utilized and desires to continue to utilize the services of the CMCMUA's System; and

WHEREAS, there presently exists a contract between the Borough of Wildwood Crest and the Authority for the use of the CMCMUA's System for the disposal, transfer, and recycling of solid waste entitled "Shared

Services Agreement for Solid Waste Disposal and Recycling Services" which will expire on December 31, 2025; and

WHEREAS, the Borough of Wildwood Crest and the Authority desire to enter into a new agreement to fix the expiration date of said Agreement to occur on December 31, 2026; and

WHEREAS, the Authority has offered the "Shared Services Agreement for Solid Waste Disposal and Recycling Services" to the Borough of Wildwood Crest in order to more efficiently provide and continue to offer municipalities within Cape May County the use of the CMCMUA's Solid Waste System from January 1, 2026 through December 31, 2026; and

WHEREAS, the Authority has submitted the same proposed form of Agreement to all Cape May County Municipalities which will provide for both solid waste disposal and certain recycling services through December 31, 2026; and

WHEREAS, N.J.S.A. 40A:65-1 et seq., the Uniform Shared Services and Consolidation Act, authorizes a municipality to enter into a contract with any other local unit for the sharing of governmental services.

NEW BUSINESS: **November 19th meeting has been moved to November 18th. Time is still 9:30 a.m.** This will remain on every agenda until then.

Go Blue Campaign: Julia from Public Works highlighted the following:

As part of the Go Blue' can recycle program, DPW is welcoming Wildwood Crest residents to join the campaign.

The first phase of the program asks WWC residents to visit our Household Trash and Recycling facility located at: 120 West Newark Ave Monday – Friday 7:00am – 2:00pm

Residents can visit the facility with their Free Recycle permit and current Red Recycle Can. At the facility, we will exchange one can per household. A program has been established to reuse and recycle the collected red cans, while earning recycling credits.

You can keep your extra red can until we roll out our second phase in late October. DPW will swap out your red can curbside during your recycle collection day.

Blue' is the universally accepted color for recycled containers and our goal is to GO BLUE, borough- wide by early spring.

Additionally, we've teamed with Terracycle, who is creating a recycled plastic statue, from recycled rigid plastics + the red cans exchanged, to craft a display statue at the crest arts pavilion building. Also, DPW has designated a specific dumpster at the Recycling facility to collect rigid materials for the sculpture until the end of Nov. Please spread the word and help us collect as many beach toys and rigid plastics for our new sculpture coming next spring.

Crest Arts Pavilion Hours: Monday, Tuesday, Thursday, Friday and Saturday from 9:00 am – 2:00 pm. The Clerk just received additional recycle tags in case the CAP center is closed. The Mayor asked for another social media push to get information out.

OLD BUSINESS:

- **-Box Truck Ordinance** Still being worked on and waiting on comments from the police department. The Solicitor indicated he would revisit the draft ordinance with police input.
- -250th birthday committee- Volunteers are still being solicited; looking to set up a fall meeting (end of November).
- **-WC Municipal App-** On hold; budgetary item for 2026
- -Historical museum 2025 A volunteer will catalog and inventory items with a presentation at a later time.
- -Traffic Calming Waiting to hear back from grant writer.

- **-Back Beach Excavation**: item for 2026. In the meantime, the Environmental consultant in conjunction with the public works department will install snow fencing to capture the sand and smooth over and should be installed in October sometime.
- **-Dredging:** No movement.
- **-Washington** / **Seaview beach outfalls and capacity**: Waiting to hear about award and could be as much as 25 million from FEMA.
- -US ACE / NJ DEP Dune: No movement.
- -Borough Hall Renovations- OSK Architects have been through the building and are working on design concepts.
- **-Fishing Pier** Waiting on formal award from Cape May County Open Space for 2.5 million.
- -Trees on Atlantic the Clerk forwarded idea to Environmental Consultant, Planning Board and Green Team for their feedback

PUBLIC COMMENTS: (Five minutes maximum)

Michelle Schaefer inquired about the Ice Cream concession bid and the number of years it would be and asked about the bid process and voting on the award of the contract and mentioned a vendor relationship.

John from Marie's Flowers asked about the borough owned property at corner of Crocus Road and New Jersey Avenue and about making it a parking lot. He indicated that parking is desperately needed in the vicinity. The Mayor indicated the borough has decided to keep and maintain the property for now. He asked Commissioner Schiff to look into perhaps getting a drop off spot in front of the store.

Joe Viscomi suggested that perhaps the borough could gauge the interest of those wanting to plant trees and could either procure someone to cut and remove the existing concrete to encourage the planting of trees with the homeowner still being responsible for the maintenance.

Engineer Marc DeBlasio told the governing body that the New Jersey Society of Municipal Engineers will be presenting Wildwood Crest with a 1st place award for the Crest Arts Pavilion Exterior at the New Jersey State League of Municipalities conference next month.
